

AN ACT

1 Providing for the capital budget for fiscal year 2017-2018;
2 itemizing public improvement projects, furniture and
3 equipment projects, transportation assistance projects,
4 flood control projects, Keystone Recreation, Park and
5 Conservation Fund projects, Environmental Stewardship Fund
6 projects, State forestry bridge projects, park and forest
7 management projects, State ATV/Snowmobile Fund projects,
8 Pennsylvania Fish and Boat Commission projects, Oil and Gas
9 Lease Fund projects and Motor License Fund projects to be
10 constructed, acquired or assisted by the Department of
11 General Services, the Department of Conservation and Natural
12 Resources, the Department of Environmental Protection, the
13 Department of Transportation or the Pennsylvania Fish and
14 Boat Commission, together with their estimated financial
15 costs; authorizing the incurring of debt without the approval
16 of the electors for the purpose of financing the projects to
17 be constructed, acquired or assisted by the Department of
18 General Services, the Department of Environmental Protection,
19 the Department of Transportation or the Pennsylvania Fish and
20 Boat Commission; authorizing the use of current revenue for
21 the purpose of financing the projects to be constructed,
22 acquired or assisted by the Department of Conservation and
23 Natural Resources or the Department of Transportation stating
24 the estimated useful life of the projects; and making
25 appropriations.

26 The General Assembly of the Commonwealth of Pennsylvania
27 hereby enacts as follows:

28 Section 1. Short title.

29 This act shall be known and may be cited as the Capital

1 Budget Project Itemization Act of 2017-2018.

2 Section 2. Total authorizations.

3 (a) Public improvements.--The total authorization for the
4 additional capital projects in the category of public
5 improvement projects itemized in section 3 and to be acquired or
6 constructed by the Department of General Services, its
7 successors or assigns, and to be financed by the incurring of
8 debt shall be \$5,145,394,000.

9 (b) Furniture and equipment.--The total authorization for
10 the additional capital projects in the category of public
11 improvement projects consisting of the acquisition of original
12 movable furniture and equipment to complete public improvement
13 projects itemized in section 4 and to be acquired by the
14 Department of General Services, its successors or assigns, and
15 to be financed by the incurring of debt shall be \$87,250,000.

16 (c) Transportation assistance.--The total authorization for
17 the capital projects in the category of transportation
18 assistance projects itemized in section 5 with respect to which
19 an interest is to be acquired in or constructed by the
20 Department of Transportation, its successors or assigns, and to
21 be financed by the incurring of debt shall be \$1,206,081,000.

22 (d) (Reserved).

23 (e) Flood control.--The total authorization for the capital
24 projects in the category of flood control projects itemized in
25 section 7 and to be constructed by the Department of
26 Environmental Protection, its successors or assigns, and to be
27 financed by the incurring of debt, shall be \$63,227,000.

28 (f) Keystone Recreation, Park and Conservation Fund.--The
29 total authorization for the capital projects in the category of
30 public improvement projects itemized in section 8 and to be

1 constructed by the Department of Conservation and Natural
2 Resources, its successors or assigns, and to be financed from
3 current revenues in the Keystone Recreation, Park and
4 Conservation Fund shall be \$64,802,000.

5 (g) Environmental Stewardship Fund.--The total authorization
6 for the capital projects in the category of public improvement
7 projects itemized in section 9 to be acquired or developed by
8 the Department of Conservation and Natural Resources and to be
9 financed by current revenues of the Environmental Stewardship
10 Fund under executive authorization shall be \$19,035,000.

11 (h) State forestry bridge projects.--The total authorization
12 for the capital projects itemized in section 10 to be
13 constructed by the Department of Conservation and Natural
14 Resources, its successors or assigns, and to be financed by oil
15 company franchise tax revenues under 75 Pa.C.S. § 9502(a)(2)(iv)
16 (relating to imposition of tax) shall be \$24,462,000.

17 (i) Parks and forest management projects.--The total
18 authorization for the capital projects in the category of public
19 improvement projects itemized in section 11 with respect to
20 which an interest is to be acquired in or constructed by the
21 Department of Conservation and Natural Resources, its successors
22 or assigns, and to be financed from current revenues in the
23 Motor License Fund, shall be \$5,558,000.

24 (j) State ATV/Snowmobile Fund.--The total authorization for
25 the capital projects itemized in section 12 to be constructed by
26 the Department of Conservation and Natural Resources, its
27 successors or assigns, and to be financed from current revenues
28 in the State ATV/Snowmobile Fund, shall be \$350,000.

29 (k) Fish Fund and Boat Fund.--The total authorization for
30 the capital projects in the category of public improvement

1 projects itemized in section 13 to be acquired or developed by
2 the Pennsylvania Fish and Boat Commission and to be financed by
3 the incurring of debt or by current revenues of the Fish Fund
4 and the Boat Fund pursuant to executive authorization shall be
5 \$23,186,000.

6 (l) Oil and Gas Lease Fund.--The total authorization for the
7 capital projects in the category of public improvement projects
8 itemized in section 14 to be acquired or developed by the
9 Department of Conservation and Natural Resources and to be
10 financed by current revenues of the Oil and Gas Lease Fund
11 pursuant to executive authorization shall be \$5,000,000.

12 (m) Motor License Fund.--The total authorization for capital
13 projects in the category of public improvement projects itemized
14 in section 15 with respect to which an interest is to be
15 acquired in or constructed by the Department of Transportation,
16 its successors or assigns, and to be financed by the incurring
17 of debt or from current revenues in the Motor License Fund shall
18 be \$1,477,950,000.

19 Section 3. Itemization of public improvement capital projects.

22 Department of General Services, its successors or assigns, and
23 to be financed by the incurring of debt, are hereby itemized,

7 Section 16. Debt authorization.

8 (a) Public improvements.--The Governor, Auditor General and
9 State Treasurer are hereby authorized and directed to borrow
10 from time to time in addition to any authorization heretofore or
11 hereafter enacted, on the credit of the Commonwealth, subject to
12 the limitations provided in the current capital budget, money
13 not exceeding in the aggregate the sum of \$5,145,394,000.

14 (b) Furniture and equipment.--The Governor, Auditor General
15 and State Treasurer are hereby authorized and directed to borrow
16 from time to time in addition to any authorization heretofore or
17 hereafter enacted on the credit of the Commonwealth, subject to
18 the limitations provided in the current capital budget, money
19 not exceeding in the aggregate the sum of \$87,250,000 as may be
20 found necessary to carry out the acquisition and construction of
21 the public improvement projects consisting of the acquisition of
22 original movable furniture and equipment specifically itemized
23 in the capital budget.

24 (c) Transportation assistance.--The Governor, Auditor
25 General and State Treasurer are hereby authorized and directed
26 to borrow from time to time in addition to any authorization
27 heretofore or hereafter enacted, on the credit of the
28 Commonwealth, subject to the limitations provided in the current
29 capital budget, money not exceeding in the aggregate the sum of
30 \$1,206,081,000 as may be found necessary to carry out the

1 acquisition and construction of the transportation assistance
2 projects specifically itemized in a capital budget.

3 (d) (Reserved).

4 (e) Flood control.--The Governor, Auditor General and State
5 Treasurer are hereby authorized and directed to borrow from time
6 to time in addition to any authorization heretofore or hereafter
7 enacted, on the credit of the Commonwealth, subject to the
8 limitations provided in the current capital budget, money not
9 exceeding in the aggregate the sum of \$63,227,000 as may be
10 found necessary to carry out the acquisition and construction of
11 the flood control projects specifically itemized in a capital
12 budget.

13 (f) Pennsylvania Fish and Boat Commission projects.--The
14 Governor, Auditor General and State Treasurer are hereby
15 authorized and directed to borrow from time to time in addition
16 to any authorization heretofore or hereafter enacted, on the
17 credit of the Commonwealth, subject to the limitations provided
18 in the current capital budget, money not exceeding in the
19 aggregate the sum of \$23,186,000 as may be found necessary to
20 carry out the acquisition and construction of the Pennsylvania
21 Fish and Boat Commission projects specifically itemized in a
22 capital budget.

23 Section 17. Issue of bonds.

24 The indebtedness authorized in this act shall be incurred
25 from time to time and shall be evidenced by one or more series
26 of general obligation bonds of the Commonwealth in such
27 aggregate principal amount for each series as the Governor, the
28 Auditor General and the State Treasurer shall determine, but the
29 latest stated maturity date shall not exceed the estimated
30 useful life of the projects being financed as stated in section

1 18.

2 Section 18. Estimated useful life and term of debt.

3 (a) Estimated useful life.--The General Assembly states that
4 the estimated useful life of the public improvement projects
5 itemized in this act is as follows:

6 (1) Public improvement projects, 30 years.

7 (2) Furniture and equipment, 10 years.

8 (3) Transportation assistance projects:

9 (i) Rolling stock, 15 years.

10 (ii) Passenger buses, 12 years.

11 (iii) Furniture and equipment, 10 years.

12 (iv) All others, 30 years.

13 (b) Term of debt.--The maximum term of the debt authorized
14 to be incurred under this act is 30 years.

15 Section 19. Appropriations.

16 (a) Public improvements.--The net proceeds of the sale of
17 the obligations authorized in this act are hereby appropriated
18 from the Capital Facilities Fund to the Department of General
19 Services in the maximum amount of \$5,145,394,000 to be used by
20 it exclusively to defray the financial cost of the public
21 improvement projects specifically itemized in a capital budget.
22 After reserving or paying the expenses of the sale of the
23 obligation, the State Treasurer shall pay to the Department of
24 General Services the money as required and certified by it to be
25 legally due and payable.

26 (b) Furniture and equipment.--The net proceeds of the sale
27 of the obligations authorized in this act are hereby
28 appropriated from the Capital Facilities Fund to the Department
29 of General Services in the maximum amount of \$87,250,000 to be
30 used by it exclusively to defray the financial cost of the

1 public improvement projects consisting of the acquisition of
2 original movable furniture and equipment specifically itemized
3 in a capital budget. After reserving or paying the expenses of
4 the sale of the obligation, the State Treasurer shall pay to the
5 Department of General Services the money as required and
6 certified by it to be legally due and payable.

7 (c) Transportation assistance.--The net proceeds of the sale
8 of the obligations authorized in this act are hereby
9 appropriated from the Capital Facilities Fund to the Department
10 of Transportation in the maximum amount of \$1,206,081,000 to be
11 used by it exclusively to defray the financial cost of the
12 transportation assistance projects specifically itemized in a
13 capital budget. After reserving or paying the expenses of the
14 sale of the obligation, the State Treasurer shall pay to the
15 Department of Transportation the money as required and certified
16 by it to be legally due and payable.

17 (d) (Reserved).

18 (e) Flood control.--The net proceeds of the sale of the
19 obligations authorized in this act are hereby appropriated from
20 the Capital Facilities Fund to the Department of Environmental
21 Protection in the maximum amount of \$63,227,000 to be used by it
22 exclusively to defray the financial cost of the flood control
23 projects specifically itemized in a capital budget. After
24 reserving or paying the expenses of the sale of the obligation,
25 the State Treasurer shall pay to the Department of Environmental
26 Protection the money as required and certified by it to be
27 legally due and payable.

28 Section 20. Federal funds.

29 (a) Projects itemized in this act.--All money received from
30 the Federal Government for the projects specifically itemized in

1 this act are also hereby appropriated for those projects.

2 (b) Projects not requiring itemization.--Department of
3 Military and Veterans Affairs construction projects which are
4 totally federally funded and to be administered by the
5 Department of General Services are hereby authorized.

6 Section 21. Delegation.

7 Notwithstanding any provision of law to the contrary, the
8 Department of General Services may delegate the design and
9 construction of the projects contained in:

10 (1) Section 3(1)(iii) of this act to The Pennsylvania
11 State University.

12 (2) Sections 3(a)(1)(ii)(B) and 6(a)(51)(ii)(EEE), (FFF)
13 and (OOO) of the act of November 1, 2013 (P.L.680, No.85),
14 known as the Capital Budget Project Itemization Act of 2013-
15 2014, to the University of Pennsylvania.

16 (3) Section 3(6)(ix) of the act of July 7, 2006
17 (P.L.390, No.83), known as the Capital Budget Project
18 Itemization Act of 2005-2006, to the University of
19 Pennsylvania.

20 Section 22. Editorial changes.

21 In editing and preparing this act for printing following the
22 final enactment, the Legislative Reference Bureau shall insert
23 or revise letters or numbers for projects where the letters or
24 numbers are missing or require revision. The Legislative
25 Reference Bureau shall also revise the total monetary amounts
26 for the total authorization, debt authorization, appropriations
27 and department totals as necessary to agree with the total
28 monetary amounts of the projects.

29 Section 23. Effective date.

30 This act shall take effect immediately.
