IMPORTANT REMINDER: All providers must revalidate the Medical Assistance (MA) enrollment of each service location every 5 years. Providers should log into PROMISe to check the revalidation dates of each service location and submit revalidation applications at least 60 days prior to the revalidation dates. PURPOSE:

The purpose of this bulletin is to issue updated handbook pages that include the requirements for prior authorization and the type of information needed to evaluate the medical necessity of prescriptions for Urinary Anti-Infectives submitted for prior authorization.

SCOPE:

This bulletin applies to all licensed pharmacies and prescribers enrolled in the Medical Assistance (MA) Program and providing services in the fee-for-service delivery system. Providers rendering services in the MA managed care delivery system should address any questions related to Urinary Anti-Infectives to the appropriate managed care organization.

BACKGROUND:

The Department of Human Services' (Department) Pharmacy and Therapeutics (P&T) Committee reviews published peer-reviewed clinical literature and recommends the following:

- Preferred or non-preferred status for new drugs in therapeutic classes already included in the Preferred Drug List (PDL);
- Changes in the status of drugs on the PDL from preferred to non-preferred and non-preferred to preferred;
- New quantity limits;
- Classes of drugs to be added to or deleted from the PDL; and
- New guidelines or revisions to existing guidelines to evaluate the medical necessity of prescriptions submitted for prior authorization.

DISCUSSION:

During the May 15, 2019, meeting, the P&T Committee recommended adding Monurol (fosfomycin) and methenamine-containing agents to the PDL. These agents have similar indications to the agents included in the existing Nitrofurantoin Derivatives PDL class of drugs. The committee recommended combining these agents into a single PDL class titled Urinary Anti-Infectives and revising the guidelines to determine medical necessity to reflect that U.S. Food and Drug Administration-approved indications and medically accepted uses will be taken into account when reviewing requests for non-preferred agents in this class.

The revisions to the PDL drug class and corresponding guidelines to determine medical necessity of Urinary Anti-Infectives were subject to public review and comment and subsequently approved for implementation by the Department.

PROCEDURE:

The procedures for prescribers to request prior authorization of Urinary Anti-Infectives are located in SECTION I of the Prior Authorization of Pharmaceutical Services Handbook. The Department will take into account the elements specified in the clinical review guidelines (which are included in the provider handbook pages in the SECTION II chapter related to Urinary Anti-Infectives) when reviewing the prior authorization request to determine medical necessity.

As set forth in 55 Pa. Code § 1101.67(a), the procedures described in the handbook pages must be followed to ensure appropriate and timely processing of prior authorization requests for drugs that require prior authorization.

MEDICAL ASSISTANCE HANDBOOK
PRIOR AUTHORIZATION OF PHARMACEUTICAL SERVICES

I. Requirements for Prior Authorization of Urinary Anti-Infectives

A. Prescriptions That Require Prior Authorization

Prescriptions for Urinary Anti-Infectives that meet any of the following conditions must be prior authorized:

1. A non-preferred Urinary Anti-Infective. See the Preferred Drug List (PDL) for the list of preferred Urinary Anti-Infectives at: <https://papdl.com/preferred-drug-list>.
2. A Urinary Anti-Infective with a prescribed quantity that exceeds the quantity limit. The list of drugs that are subject to quantity limits, with accompanying quantity limits, is available at: <http://www.dhs.pa.gov/provider/pharmacyservices/quantitylimitslist/index.htm>.

EXEMPTION FROM PRIOR AUTHORIZATION: Nitrofurantoin suspension is exempt from prior authorization when prescribed for a child under 9 years of age.

B. Review of Documentation for Medical Necessity

In evaluating a request for prior authorization of a prescription for a Urinary Anti-Infective, the determination of whether the requested prescription is medically necessary will take into account whether the beneficiary:

1. For a non-preferred Urinary Anti-Infective, has a history of therapeutic failure, contraindication, or intolerance of the preferred Urinary Anti-Infectives approved or medically accepted for the beneficiary's diagnosis; **AND**
2. If a prescription for a Urinary Anti-Infective is in a quantity that exceeds the quantity limit, the determination of whether the prescription is medically necessary will also take into account the guidelines set forth in the Quantity Limits Chapter.

NOTE: If the beneficiary does not meet the clinical review guidelines listed above but, in the professional judgment of the physician reviewer, the services are medically necessary to meet the medical needs of the beneficiary, the request for prior authorization will be approved.

C. Clinical Review Process

Prior authorization personnel will review the request for prior authorization and apply the clinical guidelines in Section B. above to assess the medical necessity of a prescription for a Urinary Anti-Infective. If the guidelines in Section B. are met, the reviewer will prior authorize the prescription. If the guidelines are not met, the prior authorization request will be referred to a physician reviewer for a medical necessity determination. Such a request for prior authorization will be approved when, in the professional judgment of the physician reviewer, the services are medically necessary to meet the medical needs of the beneficiary.
