Secretary Hossain took roll call. Secretary Hossain gave some opening remarks and introduced the topic for the meeting, which was a continuation of the funding streams for behavioral health. He mentioned that there will first be some presentations to guide our understanding of the topic, then a discussion with Council members led by Dr. Finello.

The speaker from the state was from the Pennsylvania Department of Insurance, Lindsi Swartz, who is the Director – Life, Accident, and Health Rate and Policy Form Review in the Bureau of Life, Accident, and Health Insurance. The other speakers represented commercial insurance providers. They were Dr. Mike Shepherd, who is the Senior Medical Director for Behavioral Health at Geisinger Health Plan and Dr. Matthew Hurford, who is the Vice President of Behavioral Health at UPMC Insurance Division.

After the presentations, Dr. Finello led a facilitated discussion with questions that were given to Council members prior to the meeting. The results of the discussion will be used as part of the Statewide Action Plan.
