

DRIVING PRIVILEGE SANCTIONS AND RESTORATION REQUIREMENTS LETTER FACT SHEET

DRIVING PRIVILEGE SANCTIONS

A sanction is an action taken against an individual's driving privilege. A sanction can be a suspension, revocation, disqualification, cancelation, or recall. An individual does not need to be licensed to have a sanction imposed against their driving privilege. All term (i.e., set period) sanctions must be served in full. A non-term sanction such as an indefinite suspension or recall remains in effect until released.

RESTORATION REQUIREMENTS LETTER

A restoration requirements letter is a letter that lists all the requirements an individual must satisfy to restore their driving privilege. Restoration requirements are established because of the sanctioning of the driving privilege. A restoration requirements letter can be easily obtained, in real-time, for free, on PennDOT's Driver and Vehicle Services website at www.dmv.pa.gov by following the instructions below. A restoration requirements letter can also be mailed by calling PennDOT's Customer Care Center at 717-412-5300.

Instructions for obtaining a restoration requirements letter through PennDOT's website:

1. On the homepage, under "Online Services", select "Restorations" (will take you to the Restorations Options page)
2. On the Restorations Options page, select "Request Your DL Restoration Requirements Letter"
3. Follow the instructions on the next page to view and print a restoration requirements letter

To help with understanding the information listed in a restoration requirements letter, below are the various restoration requirements that could appear on a letter along with a short explanation of certain fields and requirements.

RESTORATION FEES

Restoration fees are set by law and are subject to change every two years based on the Consumer Price Index. Restoration fees can be paid online on PennDOT's website at www.dmv.pa.gov by following the instructions below.

Instructions for obtaining a restoration requirements letter through PennDOT's website:

1. On the homepage, under "Online Services", select "Restorations" (will take you to the Restorations Options page)
2. On the Restorations Options page, select "Pay Your Driver's License Restoration Fee"
3. Follow the instructions on the next page to pay your restoration fee

Date CDL driving privilege is eligible for restoration if all restoration requirements have been satisfied.

Dear MR. PENNDOT :

This is a RESTORATION REQUIREMENTS LETTER. It lists what you must do to restore your driving privilege. PLEASE BE AWARE THAT THIS LETTER DOES NOT AUTHORIZE YOU TO DRIVE. You will be notified by the Department of Transportation (PennDOT) that your driving privilege has been restored. Only after that may you drive.

An ELIGIBILITY DATE is listed above. This is the date you are eligible to have your driving privilege restored, provided no other violations are processed against your driving record. This date is effective regardless of any other dates listed within this letter.

If the paragraph below is listed, an eligibility date will not be displayed at the top of first page or the bottom of last page.

The date when you are eligible to have your driving privilege restored has not been determined. To determine this ELIGIBILITY DATE, you must resolve any issues listed in this letter as INDEFINITE SUSPENSION, INDEFINITE CANCEL, INDEFINITE RECALL, and/or PRISON RELEASE REQUIREMENT.

Be sure to review all information listed.

Please read the following information carefully and be sure to complete all requirements to have your driving privilege restored. Unless another address is indicated, return any documents and/or fees to the MAILING ADDRESS listed at the end of this letter.

Restoration fee for non-CDL sanction (suspension or revocation). Restoration fee can be paid online. Restoration fee is subject to change every two years based on Consumer Price Index.

RESTORATION FEE

-Currently, you must pay a \$79.00 restoration fee to PennDOT. This fee is based on the Consumer Price Index and subject to change. To pay your restoration fee, you can mail a check or money order made payable to PennDOT. To ensure proper credit, write your driver's license number (listed above) on the check or money order. You can also visit our website at www.dmv.pa.gov to pay your restoration fee online.

Restoration fee for CDL sanction (disqualification). Restoration fee can be paid online. Restoration fee is subject to change every two years based on Consumer Price Index.

RESTORATION FEE

-Currently, you must pay a \$112.00 CDL restoration fee to PennDOT. This fee is based on the Consumer Price Index and subject to change. To pay your restoration fee, you can mail a check or money order made payable to PENNDOT. To ensure proper credit, write your driver's license number (listed above) on the check or money order. You can also visit our website at www.dmv.pa.gov to pay your restoration fee online.

Restoration fee for chemical test refusal sanction (suspension). Restoration fee can be paid online. Restoration fee increases for second and subsequent violations. Restoration fee is subject to every two years change based on Consumer Price Index.

RESTORATION FEE

-Currently, you must pay a \$538.00 chemical test refusal restoration fee to PennDOT. This fee is based on the Consumer Price Index and subject to change. A chemical test refusal restoration fee must be paid by certified check or money order. To pay your restoration fee, you can mail your CERTIFIED CHECK or MONEY ORDER made payable to PennDOT. To ensure proper credit, write your driver's license number (listed above) on the CERTIFIED CHECK or MONEY ORDER. You can also visit our website at www.dmv.pa.gov to pay your restoration fee online. FAILURE TO SUBMIT A CERTIFIED CHECK OR MONEY ORDER WILL DELAY THE RESTORATION OF YOUR DRIVING PRIVILEGE.

PROOF OF INSURANCE is motor vehicle insurance.

PROOF OF INSURANCE

-Within 30 days of your ELIGIBILITY DATE, provide a copy of one of the following to PENNDOT to show that all motor vehicles currently registered in Pennsylvania in your name are insured:

- *Insurance ID card
- *Declaration page of your insurance policy
- *Insurance Binder
- *An application of insurance to the PA Auto Insurance Plan

If you do not own a motor vehicle currently registered in Pennsylvania, send a signed statement of this fact to PENNDOT which reads "I do not own any motor vehicles currently registered in Pennsylvania". Please include your name, address, driver's license number and date of birth on the statement.

Court reported failure to respond to a traffic citation. Suspension is indefinite until Court notifies PennDOT that fine and cost for the citation has been paid in full or a payment installment agreement has been reached.

INDEFINITE SUSPENSION

-You did not respond to a traffic citation (K111) in the following court:

Contact the court to satisfy the citation. (If the court information does not appear, write or call PENNDOT at the address or phone number listed at the end of this letter).

Motor vehicle judgment filed. Suspension is indefinite until judgment is satisfied (paid in full) or a payment installment agreement is reached with the judgment creditor.

INDEFINITE SUSPENSION

-A judgment, resulting from an accident in which you were involved, was filed in the following court:

To satisfy this judgment, you must do one of the following:

(1) Provide PENNDOT with an official document, signed and sealed, from the District Court indicating the judgment was paid in full or,

(2) Provide PENNDOT with a letter of agreement from the judgment creditor that payments will be made on a regular basis. The judgment creditor is the person or company who filed the judgment against you.

For DUI offenses. Once the Court is notified of successful completion of treatment by the Probation Office, the Court will notify PennDOT.

COURT ORDERED TREATMENT PROGRAM (ACT 122)

-You must successfully complete the treatment program for alcohol or drug addiction ordered by the Court of YORK COUNTY, Court Number K1132, Court Term 2021. The Court must certify to PENNDOT that you completed the treatment program. PENNDOT recommends that you CONTACT YOUR PROBATION OFFICER and/or the Court to ensure that PENNDOT is properly notified.

Mainly for DUI offenses. Once the Court is notified of the completion of the prison term by the Probation Office, the Court will notify PennDOT.

PRISON RELEASE REQUIREMENT (ACT 151)

-The Court has sentenced you to serve a prison term. Pursuant to Section 1541 of the Vehicle Code, the term of imprisonment for your violation does not count toward serving your suspension/revocation or any additional suspension/revocation. The Court must certify to the Department that your prison term is completed. The Department recommends that you CONTACT YOUR PROBATION OFFICER and/or the Court to ensure that the Department is properly notified.

For DUI offenses and chemical test refusal violations.

IGNITION INTERLOCK SYSTEM

You are required to have an approved Ignition Interlock System installed in your vehicle(s). Approximately 30 days before your ELIGIBILITY DATE, you should contact one of the approved vendors to make arrangements for system installation. If you do not own a vehicle, you must still contact one of the vendors to have a certificate of non-ownership completed.

For a list of approved vendors go to the Pennsylvania DUI Association's webpage "padui.org" and click on the Ignition Interlock link at the bottom of the home page. If you do not have access to the internet, please call the Pennsylvania DUI Association at 1-800-627-2384 for vendor information.

TERM SUSPENSION/REVOCATION

-You have a 5 YEAR(S) suspension/revocation that began(or will begin) on 01/12/22 and will end on 01/12/27. The suspension/revocation resulted from a violation on 12/01/21 of Section 3802B, DUI BAC .10-<.16

TERM DISQUALIFICATION

-You have a 1 YEAR(S) disqualification that began (or will begin) on 06/01/21 and will end on 06/01/22. It resulted from a violation on 04/01/21 of Section A3802B, ARD-DUI BAC .10-<.16

For DUI offenses and chemical test refusal violations.

IGNITION INTERLOCK LICENSE

-In order to have your driving privilege restored, you must apply for an Ignition Interlock license. An Ignition Interlock license entitles you to drive vehicles equipped with an Ignition Interlock System only. You may make application 30 days before your ELIGIBILITY DATE. An application is enclosed for your convenience.

To apply for an Ignition Interlock license, please sign below and submit this page with a check or money order to the address listed below.

Our records indicate that your driver's license will expire within the next 6 months. If you would like to renew at this time, make your check or money order payable to PENNDOT in the amount of \$30.50.

If you do not wish to renew at this time submit a check or money order in the amount of \$31.50 to receive your Ignition Interlock License. You will receive an invitation to renew at a later date.

IGNITION INTERLOCK LEARNER'S PERMIT ←

You must apply for an Ignition Interlock learner's permit in order to have your driving privilege restored. An Ignition Interlock learner's permit allows you to only operate vehicles equipped with an Ignition Interlock System. You may make application 30 days BEFORE your eligibility date.

For DUI offenses where the driving privilege was revoked.

If an eligibility date DOES appear at the end of this letter and you are WITHIN 30 days of that date, visit PennDOT's website at www.dmv.pa.gov to download a copy of the most recent version of the Pennsylvania Driver's Manual and the Non-Commercial Learner's Permit Application (DL-180) which is required to be completed prior to applying for a learner's permit. Once you have studied the manual and had a physical, please return to a Driver License Center with this letter, your completed Non-Commercial Learner's Permit Application (DL-180) and a check or money order for all necessary fees. You will be given a vision test and a traffic signs and knowledge test at that time.

If you are currently licensed in another state, you must provide to PENNDOT, proof of residency before your driving privilege will be restored in Pennsylvania. Acceptable documents for proof of residency for applicants 18 years of age or older are:

- * Current utility bills (water, gas, electric, cable, etc.)
- * Tax records
- * Lease agreements
- * W-2 form
- * Current weapons permit

Please note: All documents must show the same name and/or date of birth, or an association between the information on the documents. Additional documentation may be required if a connection cannot be established.

An Ignition Interlock learner's permit restricts you to operating only vehicles equipped with an Ignition Interlock system.

You are required to have an approved Ignition Interlock System installed in your vehicle(s). Approximately 30 days before your ELIGIBILITY DATE, you should contact one of the approved vendors to make arrangements for system installation. If you do not own a vehicle, you must still contact one of the vendors to have a certificate of non-ownership completed.

For a list of approved vendors go to the Pennsylvania DUI Association's webpage "padui.org" and click on the Ignition Interlock link at the bottom of the home page. If you do not have access to the internet, please call the Pennsylvania DUI Association at 1-800-627-2384 for vendor information.

This letter identified the requirements necessary to restore your driving privilege and we are looking forward to working with you to do this. Unless another address was indicated, return any documents and/or fees to the MAILING ADDRESS listed below. Phone numbers are provided for your use. To ensure prompt customer service, please write your driver's license number, listed at the beginning of this letter, on all documents you send to PENNDOT. Thank you.

Date non-CDL or CDL driving privilege is eligible for restoration if all restoration requirements have been satisfied.
