

## MILITARY COMMERCIAL DRIVER'S LICENSE (CDL) TEST WAIVER APPLICATION

## **MUST BE A PENNSYLVANIA RESIDENT TO APPLY**

Per 49 CFR 383.77, the Commercial Driver License (CDL) test waiver form may be used by service members who are currently licensed and who are or were employed within the last year in a military position requiring the operation of a military motor vehicle equivalent to a Commercial Motor Vehicle (CMV). This waiver allows a qualified service member to apply for a CDL without knowledge and/or skills testing provided there is sufficient evidence to support the waiver. CDL knowledge (written) test(s) for doubles and triples/school bus cannot be waived. The transfer of School Bus(S) under this Waiver Program is prohibited.
