# APPLICATION FOR PAYMENT OF CIVIL PENALTY IN LIEU OF REGISTRATION SUSPENSION

PennDOT offers the ability for you to pay a civil penalty in lieu of serving a three month registration suspension. The civil penalty is \$500 and is in addition to the restoration fee. **NOTE: Customers may opt for the civil penalty in lieu of suspension no more than once in a 12 month period.** Payment of the civil penalty, along with the restoration fee **and proof of current insurance**, will allow customers to maintain registration on their vehicle without the requirement to serve a three month registration suspension.
